

Members of the New Governor's Water Policy Council Announced

On May 4, Governor Katie Hobbs announced the members she has selected to serve on her new Governor's Water Policy Council. The Council, which was created by Executive Order, will develop policy and legislative recommendations for the governor, and includes bipartisan representation from "the Arizona legislature, executive agency cabinet directors, water providers, cities, the development community,



agriculture, industry, conservation organizations, university experts, and more." WRRC Director Sharon B. Megdal is among those selected to serve. The council will begin by focusing on rural groundwater policies and Assured Water Supply. Their first meeting is scheduled for May 17, 2023.

Final NVIS Seminar of the Spring Semester

On May 3, University of Arizona graduate students Chantel Harrison and Jaymus Lee, both Diné, presented their research for the final UArizona Native Voices in Stem (NVIS) seminar of the Spring 2023 semester. Lee began with a presentation on "Off-Grid CEA"

Greenhouse for Food Production: A Collaborative Pilot Project between Diné College and the University of Arizona." Lee shared his work on off-grid greenhouse and hydroponic system designs, including the renovation of a high tunnel hoop house. He is studying Applied Biosciences in the Professional Science Masters (PSM) program in Controlled Environment Agriculture (CEA). Harrison followed with a presentation titled "Indigeponics: Indigenizing Controlled Environment Agriculture." She is also studying CEA within the PSM program and is an IndigeFEWSS Fellow, Sloan Scholar, and Native Pathways Fellow. Harrison's work focuses on sustainable



food systems in Indigenous communities through CEA. She leads an Indigenous greenhouse research project, Indige Planted LLC, in partnership with indigenous growers and organizations. The presentations were followed by a Q&A. A recording of the seminar will be posted soon to the NVIS seminar library.

Women in Water Diplomacy Network Releases After Action Report

The Women in Water Diplomacy Network has released their After Action Report for the UN 2023 Water Conference and Water Diplomacy Symposium. The Symposium, convened by the Women in Water Diplomacy Network with partners including the WRRC, was held in advance of the UN Conference to "enable networking, foster partnerships, and encourage information exchange" amongst those attending the UN Water Conference, "with a focus on



critical themes related to transboundary basins globally." The event gave special focus to women water leaders and was attended by water diplomats, both formal and informal, from around the world. The 80-page After Action Report provides an overview of the proceedings of the Water Diplomacy Symposium and other Women in Water Diplomacy Network events associated with the UN 2023 Water Conference — including the WRRC's webinar on conference takeaways featuring multiple special guest speakers — as well as biographies of Symposium participants and the results of a survey evaluating the Network's engagements. In addition to the After Action Report, a recording of the official Women in Water Diplomacy Network side event held during the UN Water Conference, "Elevating Critical Voices in Water Diplomacy," is now available to view on YouTube.

UArizona Profs Presented on Climate Data at SXSW

UArizona professors Joellen Russell and Beth Tellman gave a presentation, titled "Climate Data is Power – to the People," at the Wonder House South by Southwest (SXSW) conference held in Austin, TX in March 2023. Russell and Tellman, both climate scientists, discussed ways to use climate data to develop a better future. They emphasized the importance of paying attention to rising ocean levels and global temperatures and

provided predictions for future emissions. Dr. Tellman, whose research focuses on flood risk, environmental change, and land-use change to predict risk to human life and communities, outlined areas of current need by utilizing detailed maps of floods, which update in real-time! Understanding how social processes relate to climate change via satellite image pixels and satellite data is the cornerstone of her research. Dr. Russell, who is also an oceanographer, utilizes robot floats, satellites, and supercomputers to predict how the ocean will affect changes in the climate by studying the past, present, and
