

Current and Future Demands

- Domestic
 - More than \$600 million in current needs
- Agricultural
 - More than \$1 billion needed for various projects
- Cultural
 - Important throughout the Navajo Nation
- Municipal
 - Many current systems not sized for municipal demands
 - Upgrades are needed for many systems
 - Studies being conducted.
- Industrial
 - Major part of economy until other sectors of business can participate
